Professional Qualification Framework Requirements

To ensure that a consistent standard is achieved for adjudicators, all organisations that provide qualifications and wish to have these accepted by the NZRDI competitions /events must ensure their processes meet the following framework.

This framework has been designed so all organisations understand the minimum standards required for qualifications to be accepted.

- Professional societies must have freely available:
 - The different levels of professional examination available by the society, including pre requirements (i.e. Level 1 must be attained before level 2).
 - The syllabus that the candidate will be examined on at each level including: Examination duration, practical and theory components.
 - A structured passing or grading process that is understood by candidates.
 - Costs for each examination.
 - A dispute process for candidate results
- Professional Societies professional examination processes must include:
 - A process for ensuring independent assessment free from favour.
 - A clear process for selecting their examiners capability and suitability.
 - A documented moderation process for their examiners to ensure consistency in results from different candidates.
 - A process that ensures the candidate can be assessed as to their attainment to the standard required.
- The NZRDI Framework must ensure qualifications accepted from societies:
 - Enable adjudicators to appropriately assess competitors to the recognised standards of the style of dance.
 - Can ensure compliance NZRDI competition rules regarding figures and routine construction with restrictions in the formative grades of the dance style.
 - Cover the understanding of the fundamentals of dance and dance principles related to that style.
 - Understand the role of adjudication has in development of dance, including the values of NZRDI when adjudicating.
 - Has a mechanism for ensuring the ongoing suitability of the qualification.
